I understand the fee for the bride's hair styling will be \$\_\_\_\_\_, which includes, day of styling (as practiced at the pre-wedding consultation.)\* Bridesmaids and other members of the wedding party need to be paid for, and will be included in the total cost and deposit. Pre-wedding consultation fee is \$75.00 for hair. Consultation fee will need to be paid for the same day as the consultation, along with the 40% deposit to secure the wedding date. On site fee is a minimum of \$50.00 or \$100.00/hour drive time, to cover travel costs and transportation of supplies.

- \* Brides hair: \$125.00-\$225.00 (Depending on length and design)
  - \* Bridesmaids hair: \$75.00 (Short hair) \$95.00-\$115.00 (Med-Long lengths or intricate designs)
  - \* Mother of the Bride & Groom: \$65.00-\$125.00 (Each)
  - \* Flower girls, or small children: \$55.00 each

A 40% non-refundable deposit by cash or check will be required to secure the date, when the contract is signed. Balance will be due on the day of the wedding, before services begin. Cash or check only. If wedding participants fail to pay the total amount agreed upon above, services for that day will not be provided. If the contract is canceled before the day of the wedding, for any reason, services already provided (deposit included) is non-refundable.

**\*All members of the wedding party receiving hair services need to be present and ready to have hair done by the time the hair stylist arrives. All hair must be DRY, as the stylist will not have time or the tools that day to provide that service (unless requested and added into contract). If a member of the wedding is not on time, or cannot be found at the time of their service, the stylist will not wait for them and the service will still have to be paid for in full. All hair products and supplies will be provided in the total cost, other hair accessories, flowers, and extra added items will need to be provided by the bride and wedding party members.**

**I agree to the terms of the contract and will provide all information to other members of my wedding party who will be receiving services.**
